**PROHIBITION OF MOTOR VEHICLES  
(WITH EXEMPTIONS)**

Leeds City Council in exercise of the powers contained in Sections 1 and 2 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act") and of all other powers so enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with those persons and organisations specified in the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 hereby makes the following Order:-

1. For the purposes of this Order "**motor vehicle**" has the same meaning as in Section 136 of the 1984 Act
2. No person shall except upon the direction of or with the permission of a police constable in uniform or of a traffic warden cause or permit any motor vehicle other than a motor vehicle requiring access to or egress from land or buildings on or adjacent to the length of road to proceed in the length of road specified in the Schedule to this Order
3. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made or having effect as if made under the 1984 Act or by or under any other enactment

Access Road to the former Boot & Shoe Public House Ledsham Leeds	From a point 58 metres west of the projected south western kerb line of the Great North Road in a westerly direction to a point 53 metres south of the projected southern kerb line of A63 Selby Road

4. For the avoidance of doubt any reference in this Order to a length of road shall be deemed to be a reference to more than one length of road where the context requires it
5. This Order is made on the 23<sup>rd</sup> day of June 2008 and shall come into force on the 25<sup>th</sup> day of June 2008 and shall be cited as the "Leeds City Council (Traffic Regulation) (Movement Restriction) (No.M16) Order 2007"
