30 MPH SPEED LIMIT

Leeds City Council in exercise of the powers contained in Sections 82(2), 83(2) and 84(1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act") and of all other powers so enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with the persons and organisations specified in the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 hereby makes the following Order:-

1. This Order is made on the *23rd* day of *September* 2008 and shall come into force on the *26th* day of *September* 2008 and may be cited as the "Leeds City Council (Speed Limit) (No.13) Order 2007"
2. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour in the length of road specified in the First Schedule to this Order.
3. The Orders specified in Column 1 of the Second Schedule to this Order are hereby amended/revoked to the extent specified in Column 2 of the said Second Schedule
