STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

Following the introduction of a resident permit parking scheme on Kerry Hill, Kerry Garth, Kerry Street and Kerry View, Horsforth in August 2008, the residents of Kerry View, which is a private street, have now decided that they no longer want to be included in the resident permit parking zone, because they are concerned that residents from the adjoining streets will start to park on their private street.

It is therefore proposed to amend the Leeds City Council (Parking Places) (No.18) Order 2007 to remove Kerry View from the resident permit parking schedule.

AMENDMENT OF EXISTING PARKING PLACES ORDER

Leeds City Council proposes to make the above Order under its powers contained in the Road Traffic Regulation Act 1984 the effect of which will be to amend the Leeds City Council (Parking Places) (No.18) Order 2007 to remove reference to Kerry View from the First Schedule (Residents Permit Parking) to that Order.
