MANDATORY LEFT TURN


Leeds City Council (hereinafter referred to as "the Council") in exercise of the powers contained in Sections 1 and 2 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act") and of all other powers so enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with those persons and organisations specified in the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 hereby makes the following Order:-

- 1 Save upon the direction of or with the permission of a police constable in uniform or of a traffic warden every person causing a vehicle to proceed in the length of road referred to in Column 1 of the Schedule to this Order shall cause that vehicle on reaching the road referred to in Column 2 of the said Schedule to make a left turn into that road

- 2 The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the 1984 Act or by or under any other enactment

3. For the avoidance of doubt any reference in this Order to a length of road shall be deemed to be a reference to more than one length of road where the context requires it
4. This Order is made on the 14th day of November 2008 and shall come into force on the 17th day of November 2008 and may be cited as the "Leeds City Council (Traffic Regulation) (Movement Restriction) (No. M8) Order 2008"
