**MOORLAND ROAD & OCCUPATION LANE BRAMHOPE**

**30MPH SPEED LIMIT**

Leeds City Council has today made the above Order under its powers contained in the Road Traffic Regulation Act 1984. The effect of the Order which comes into effect on Monday 15 August 2011 is to introduce a 30MPH Speed Limit on the whole lengths of Moorland Road and Occupation Lane Bramhope.

A copy of the Order together with a plan showing the affected sections of highway may be examined during normal office hours at the Legal Services Reception Desk, 1<sup>st</sup> Floor, St George House, Great George Street, Leeds 1 and at Otley Library Nelson Street Otley LS21 1EZ.

If you wish to question the validity of the Order or any provision contained in it on the ground that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or an instrument made under the Act has not been complied with in relation to the Order, you may within six weeks from the date upon which the Order was made, apply to the High Court for that purpose.

**MOORLAND ROAD AND OCCUPATION LANE, BRAMHOPE**

**30 MPH SPEED LIMIT**

Moorland Road and Occupation Lane are currently subject to the national speed limit for rural roads. The presence of residential properties and a campsite in regular use by the scouting movement mean that the higher limit is no longer appropriate. It is, therefore, proposed to reduce the speed limit to 30mph. This will link with the existing 30mph speed limits on Moor Road and Old Lane.

**30 MPH SPEED LIMIT**

Leeds City Council in exercise of the powers contained in Sections 82(2), 83(2) and 84(1) and (2) of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act") and of all other powers so enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with the persons and organisations specified in the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 hereby makes the following Order:-

**DEFINITIONS**

1. For the purposes of this Order:-

““Special Forces”

Those units of the home forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director.

“Special Forces Purposes”

The expression means, in relation to the use of a vehicle, the use of a vehicle by the special forces in response, or for training or practice in responding, to a national security emergency.”;

1. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour in the lengths of road specified in the Schedule to this Order.
  
2. The above prohibition shall not apply in relation to a vehicle used for naval, military or air force purposes while being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown on an occasion when
  - (a) the person driving the vehicle is a member of the special forces; and
  - (b) the vehicle is being driven
    - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving vehicles at high speeds; or
    - (ii) for the purpose of training a person in driving vehicles at high speeds.
  
3. This Order is made on the 12 day of August 2011 and shall come into force on the 15 day of August 2011 and may be cited as the "Leeds City Council (Speed Limit) (No 9) Order 2010"

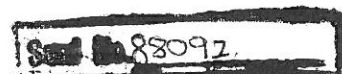
