

## Statement of Representations Procedure

### Regulation 19 of the Town and Country Planning (Local Planning) (England) Regulations 2012

#### Leeds Site Allocations Plan –Revised Submission Draft Plan

Leeds Site Allocations Plan allocates land for housing and employment and also makes designations for retail and green space across the whole of the Leeds District (except for the area covered by Aire Valley Leeds Area Action Plan). Since Submission of the Plan in May 2017, a likely lower future housing requirement for Leeds was published by DCLG as part of its consultation document planning for the right homes in the right places. In response the Council is proposing a Revised Submission Draft Site Allocations Plan which reduces the release of Green Belt land previously proposed for housing by designating some sites as 'Broad Locations for Growth' which shall remain in the Green Belt for future review.

Representations are invited on the revisions to the Submission draft Plan for a period of six weeks beginning on **15th January 2018 until 26th February 2018**. Representations should be made in writing or by email and returned to the addresses below no later than **26th February 2018 (5pm)**.
