1. An election is to be held for **1 (one)** Councillor to serve each of the 33 wards listed above.
2. Nomination papers must be delivered to the Returning Officer at **Electoral Services, Level 2, Town Hall, The Headrow, Leeds LS1 3AD** between **9am and 4pm** on any working day from the date of publication of this notice (excluding bank holidays) but **no later than 4pm on Wednesday 3 April 2019**.
3. Nomination papers may be obtained from the offices of the Returning Officer at **Electoral Services, Level 2, Town Hall, The Headrow, Leeds LS1 3AD** or online from www.leeds.gov.uk/elections.
4. If any election is contested the poll will take place on **Thursday 2 May 2019**.
5. Applications to register to vote must reach the Electoral Registration Officer by **midnight on Friday 12 April 2019**. Applications can be made online: www.gov.uk/register-to-vote.
6. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at **Electoral Services, Level 2, Town Hall, The Headrow, Leeds LS1 3AD** by **5pm on Monday 15 April 2019**.
7. Applications to vote by proxy at this election must reach the Electoral Registration Officer at **Electoral Services, Level 2, Town Hall, The Headrow, Leeds LS1 3AD** by **5pm on Wednesday 24 April 2019**.
8. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at **Electoral Services, Level 2, Town Hall, The Headrow, Leeds LS1 3AD** by **5pm on Thursday 2 May 2019**. The physical incapacity must have occurred after 5pm on Wednesday 24 April 2019. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday 24 April 2019.
